One and Two Family Residential Plan Review Deposit: (If required by Township)

\$100.00 – The deposit is non-refundable but is applied to the permit fee when applicable.

Commercial Plan Review Deposit: (If required by Township)

\$500.00 plus any additional review fees. If the review fee is less than the initial deposit of \$500.00, the remainder will be applied to the building permit fees or refunded to applicant. For projects where the cost would not exceed \$500.00 the plan review deposit may be waived.
